Sherwood School District has about 4,400 students attending four elementary schools, one middle school, and one high school. High school graduation rates are among the highest in the state – 94% in 2022. The new Sherwood High opened in the fall of 2020, with a 73-acre campus and state-of-the-art facilities. The district is one of the city's largest employers, with about 600 dedicated teachers and staff.
