### **The District**





**Butte Falls Charter School District** serves approximately 130 students with campuses for grades K-7 and 8-12 as well as the Butte Falls Natural Resource Center, an integral component of the district's system. The District employs a staff of 14 licensed employees, 18 classified employees, 1 confidential employee and 3 administrators.

The District has a general fund budget of about \$4.37 million. The district recently renewed accreditation through Cognia for grades K-12. It has a partnership with Rogue Community College for dual credit, and the Natural Resource Center is a fully sanctioned Outdoor School facility. The 13-acre property is used extensively for project-based learning.

The District offers personalized education plans for students, with opportunities including a metal manufacturing lab, a commercial kitchen and a comprehensive wood and construction manufacturing lab as well as a local work experience program. The district has a SMART Reading program, a high school regional math team, and school-based health care in partnership with Rogue Community Health.
